Administrative Procedure 308 - Sexual Orientation Gender Identity

Amber Hester, Assistant Superintendent - Inclusive Learning Services, provided an update on the status of Administrative Procedure 308. Wolf Creek has submitted this administrative procedure, as per the Minister's request for review, to comply with the March 31, 2016 deadline. Details were provided outlining the next steps which include the development of a strategic focus on this topic. There are a large number of resources that are available to school divisions from Alberta Education, ATA and a variety of agencies. Wolf Creek Public Schools is committed to create a strategic focus that will assist our schools in meeting the legislated requirements.
