SUPERINTENDENT'S REPORT Office of the Superintendent for September 21, 2017

Enhanced Learning Model (ELM) Overview

Over 150 Wolf Creek high school students accessed the Enhanced Learning Courses in 2016-2017 to support their course delivery. The ELM Courses are making a difference for our students and assisting our staff with strong content delivery. This summary outlines the progress and results achieved through this innovative model.

Learning Beyond the Classroom - Dual Credit and HS ReDesign

Five students from Bentley School will be participating in the Rig Training Program near the end of September. This partnership is in Year 2 with Northern Lights School Division and the commentary from parents and students has been extremely positive. Additional conversations are taking place with Red Deer College around dual-credit opportunities as selected students from WCPS will have this opportunity in Semester 2 this year.

Literacy Supports and Training

Staff from schools across WCPS were provided with two upcoming PD opportunities to be part of Leveled Literacy Intervention (LLI) training this Fall. This training allows teachers new to the profession or teachers unfamiliar with this intervention to receive support in implementing literacy assessments and intervention programs for students in K-9. A recent PD event was also held for Read 180 teachers as we have this program expanding in two Outreach schools and new teachers in some other school sites.

Bright Futures Play Academy & Kindergarten Cohort



Staggered entry for pre-kindergarten started and we have additional families still registering for remaining spots. We have strong pre-k enrolment numbers with many children qualifying for additional supports through provincial funding that will benefit from early intervention. Teachers have also received some additional professional development during start-up dates on speech and language supports. Some of this training has also involved our pre-kindergarten teachers working with kindergarten teacher colleagues to build coherence between Age 3 to Age 5 programs on speech and language support focused on articulation. This took place on September 15.

Safe and Caring Schools Audit Schedule

We are excited to share that the Safe and Caring Schools Review will be underway soon. The Safe and Caring Schools Committee met with Administrators on Sept. 20th to review the process and expectations. There was a schedule created that starts the week of November 6th and finishes April 25th. The review includes: interviews with staff, surveys of staff and students and a parent feedback component. Once all the data has been collated the school receives a report with the data and recommendations on areas for growth.
