SUPERINTENDENT'S REPORT Office of the Superintendent for October 19, 2017

Continued Partnerships for Dual Credit and High School ReDesign

Learning Services recently had a chance to tour the Bonnyville site and meet with educational leaders in Northern Lights School Division to discuss our cohort of student learning experiences with Rig Safety Training. During these discussions additional potential course offerings were examined as part of Dual Credit and High School ReDesign opportunities to bring more opportunities with trades and career exposure to students. Additional local opportunities will also be expanded in Semester 2 with career and trade exposures.

New Examination Accommodation Processes

Learning Services and Inclusive Learning Services met to discuss the implementation of new provincial exam accommodations for PAT and Diploma exams. These new processes allow for students to have access to specific universal accommodations and some extra writing time where needed without Ministry approval. However, these processes also need to be implemented while respecting the security and integrity of the assessment. Thanks to support from Technology Services, WCPS is one of the first districts in the province to have a well supported and solid accommodation process to respond to these new Ministry allowances. This will serve our students well in the coming months and years. This plan was communicated to each school principal through a visit to schools during the past few weeks starting with High Schools and will continue for other schools in the weeks ahead. Other school visits around PAT accommodations will continue soon as well.

Assignable Time Provisions

Within the collective agreement teachers have assignable time clauses which need to be calculated at the start of the year to ensure we are in compliance with the collective agreement. A team of division office leaders has been meeting with school principals to refine this calculation. This work is nearing completion and is ready to be shared with school principals.



Family Oriented Program Sessions Underway

Families with pre-kindergarten children are encouraged to attend a variety of Family Oriented Program sessions held across WCPS through support from our pre-kindergarten teachers and a number of community agency partners. This information is available <u>at this link</u> and the first session was held on October 6 for families in a variety of communities. The first event was well received by parents and community partners with Parent Link Centres providing strong parent support.

Focus and Review of AERR and Literacy Data

Recently at the WCPS Administrators' Retreat in mid October, a review of the specific data measures around school AERR Summary Reports, PAT and Diploma Exam results and a wide variety of literacy data was shared with school administrators. They will utilize this data to build specific goals in their school ACE Plan for 2017-2018. Learning Services is continuing to meet with each school principal in the coming weeks to follow up on this data review and identify some support areas to continue further growth and discuss maintaining some of the recent strong results.

Teachers Advising and Guiding (TAG) Meeting: October 17, 2017

The first TAG meeting of this year will focus on providing input and direction on the thoughtexchange data gathered last fall from a district-wide engagement. Both district and school data will be reviewed and TAG members will have an opportunity to update senior leadership on to what degree this feedback has impacted their school.
